

# Did you mistakenly sign a petition for an initiative that would raise property taxes?

Initiative #19-0003 has some good elements, but on balance it is a property tax increase.

This measure, sponsored by the California Association of Realtors, changes Proposition 60 (1986) and Proposition 90 (1988) to allow more opportunities for older homeowners to transfer their current property tax assessment to a replacement home. Additionally, it clarifies the definition of “change of ownership” for property owned by a legal entity such as a corporation.

However, initiative #19-0003 also **repeals** Proposition 58 (1986) and Proposition 193 (1996), ending the exclusion from reassessment for property transferred between parents and children or grandparents and grandchildren. This is a **tax increase**. Properties transferred within families would be reassessed to market value unless used as the primary residence of the new owner.

Initiative #19-0003 has been given the following title by Attorney General Xavier Becerra:

CHANGES REQUIREMENTS FOR TRANSFERRING PROPERTY TAX BASE TO  
REPLACEMENT PROPERTY. EXPANDS BUSINESS PROPERTY REASSESSMENT.
