**WHEREAS:** For more than 41 years, Proposition 13 has protected the security of home ownership and saved California taxpayers more than 528 billion dollars;

**WHEREAS:** The vast majority of California taxpayers want to protect Proposition 13 and keep it intact and stated that fact again by overwhelmingly passing Prop. 218 in 1996, rejecting the anti-Prop. 13 statewide parcel tax in 2006, and passing Prop. 26 in 2010 to close a loophole used to dodge Proposition 13; and

**WHEREAS:** Bills introduced in the new legislative session, if adopted, could weaken key Proposition 13 taxpayer protections, like the two-thirds majority protection and the 1% cap;
