**To: My State Senator, My Assembly Member
And the entire California State Legislature**

Whereas: Proposals to "Tax the Rich" rely on the creation of a new kind of tax, in addition to income, sales and property taxes;

Whereas: ACA 3 would allow taxation of "unrealized capital gains" on real estate, effectively ending the *purchase price* standard for property taxes, replacing it with taxation based on *current market value*. ACA 3 taxation of "unrealized capital gains" could also be applied to retirement savings;

Whereas: ACA 3 would allow the Legislature to raise taxes with a simple majority vote instead of Prop. 13's constitutionally required two-thirds vote; and

Whereas: ACA 3 would also write the Gann Limit out of the Constitution, inviting overspending without limit;

I hereby exercise my right of Petition, urging you to **VOTE NO** on ACA 3 and *any* legislation that would threaten Prop. 13's constitutionally guaranteed taxpayer protections.
